

ORD 05-33

AN ORDINANCE AMENDING THE PERMIT PARKING HOURS ON ELMINA STREET, BETWEEN OVERDALE STREET AND LYNDBURST STREET WITHIN THE SOUTH PARK DESIGNATED PARKING DISTRICT.

WHEREAS, by Ordinance adopted July 6, 1995, the City of Morgantown last amended the South Park Designated Parking District, and therein required permit parking between the hours of 7:00 a.m. and 7:00 p.m. Monday through Thursday and 7:00 a.m. to 6:00 p.m. on Friday, with Saturdays and Sundays not being permit parking days;

WHEREAS, Morgantown City Council has received a petition from the residents of Elmina Street, within the South Park Designated Parking District, requesting that the times for permit parking on Elmina Street be changed to 5:00 p.m. to 7:00 a.m. seven days each week; and

WHEREAS, Morgantown City Council is of the opinion that it should grant the foregoing request inasmuch as the petition presented in support of the change provides good explanation and justification as to why the change should be made.

NOW, THEREFORE, the City of Morgantown hereby ordains that the South Park Designated Parking District Ordinance is amended as follows (new matter underlined, deleted matter struck through.):

#### ESTABLISHMENT OF DISTRICT:

There is hereby established within the City of Morgantown pursuant to Article 367 of the Morgantown City Code a Designated Parking District to be bounded as described below, and to be identified as the "South Park Designated Parking District."

#### BOUNDARIES OF DISTRICT:

The District shall be bounded as follows:

The South Park Designated Parking District shall be limited to the properties included within the boundaries delineated on the attached map which is declared to be a part of this ordinance.

#### SIGNING OF STREETS:

The City Manager shall cause all streets within the above Designated Parking District to be signed as follows:

1. Permit Parking only between the hours 7:00 a.m. to 7:00 p.m. Monday through Thursday and 7:00 a.m. to 6:00 p.m. on Friday. Saturdays and Sundays shall not be permit parking days. An exception to the foregoing shall be on Elmina

Street beginning at Overdale Street and ending at Lyndhurst Street upon which permit parking shall be in place and enforced from 5:00 p.m. to 7:00 a.m. seven days each week.

PERMITS AVAILABLE:

Two (2) regular parking permits and one (1) visitor permit can be issued for each household in this permit parking district.

APPLICABILITY OF OTHER PARKING RESTRICTIONS:

Nothing contained herein shall be construed as permitting the parking of any vehicle in any properly marked "no parking" or restricted parking area or in violation of any other City ordinance or law.

This ordinance will be reviewed by Council upon completion of the Morgantown High School Project.


This Ordinance shall be effective as of the date of adoption.


